

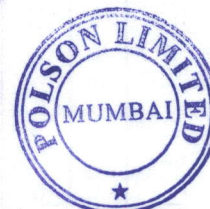

INDEPENDENT AUDITOR'S REVIEW REPORT


